

A word from Stephen Vranesic, Sales Director

Enthusiasm and passion aptly describe my spirit to the role of Sales Director at SAF-HOLLAND. I believe we have an exciting and prosperous future ahead of us, and I am proud to be part of the team.

The road transport industry is not unfamiliar to me as it was a market segment of responsibility during my 20 years at Timken. My customer base comprised of all the axle suppliers and aftermarket channels based in Victoria, and then extended Australia wide, when I became National Sales Manager. I also represented Timken at ARTSA meetings and coordinated the Brisbane Truck Show exhibits for 16 years.

Walking through the Melton warehouse, I sense a little Déjà vu, as Holland Hitch was one of my very early customers, and this is where axle assembly initially took place in Melton.

Wheel bearing training at fleet workshops taught me much in my formative years. As I travelled to almost every corner of Australia, meeting some very colourful characters along the way, I learnt the importance of listening. Australia is a very diverse country, and what works in one part of the country is not guaranteed to work in another.

More recently, I worked for Bearing Wholesalers, one of the businesses within Bapcor's Speciality Wholesale Group (SWG). My role was to manage a product portfolio that extended well beyond bearings and included all rotating mechanical items in a passenger car, excluding those internal to the engine. My responsibilities included marketing, pricing, procurement and other general product management duties, and I was responsible for the P&L and ROI performance for those groups of products.

The majority of products sold were kits assembled in house. Some kits contained more than 30 different items, with these sourced from suppliers in Europe, Asia and Australia, and private label packaging was every day. The Bearing Wholesalers product range further developed with Bapcor's entry into the truck aftermarket in 2018 (including the Truckline acquisition in 2019).

My immediate focus will be to work closely with our sales team as we strive to grow sales in axles and fifth wheels. The year ahead will be different in many respects, and we will not have the benefit of precedence.



Success will require determination, persistence and focus. I know our team has these characteristics, and I look forward to standing with them as we increase our market share. Delivering the SAF-HOLLAND value to fleets across Australia will also be imperative in the execution of our strategy, and form a crucial part of our effort.

Communication and feedback, something I learnt playing the trombone, are important to me, as you have to be open to critique to be the best you can.

On a personal note, I have a Bachelor's Degree in Engineering and currently undertaking an MBA, which I plan to complete early 2022. 2 - RECOGNIZE WHAT WE SEE

Corporate Audit then puts things into perspective, compares observed practices with applicable laws and/or Company (internal) standards and/or best practices to the extent they are known, then analyzes, summarizes, synthesizes etc.

3 – SAY WHAT WE THINK

Corporate Audit then verbalizes what it saw and observed, thereby pointing out control weaknesses and/or unexploited performance potential. The written audit report is the typical vehicle for doing that. Corporate Audit discusses the written report in full with the auditees and the local/senior management in the closing meeting.

1 - SEE WHAT WE DO

Corporate Audit first sees and appreciates what we – the Company – does. Corporate Audit is typically on site (presently we can only perform remote audits, questionnaire based, due to travel restrictions) and views, via discussions and document based walk-throughs, what is actually happening.

4 - DO WHAT WE SAY

Corporate Audit then follows-up with the respective leaders to ensure that we as a company do what we agreed to do. Corporate Audit can trigger action and help remediating and improving things, but it cannot act on behalf of the key process owners themselves, as it has no operational responsibility.



Launch of the Disk Brake Axle at SAF-HOLLAND India

As a market leader, SAF-HOLLAND is always looking for opportunities to bring York's innovative products into the Indian market.

Recently, *Satrac*, one of our major customers, received an order for 60 trailers for the Indian Army, and were looking for disc brake axles to prevent the wheels from overheating during long hilly operations.

Mr. M.C. Bantwal, Director of Satrac, asked SAF-HOLLAND to supply York disc brake axles not only in a short lead-time, but to also manufacture these axles in the Indian plant to reduce cost.

As India is a low cost market, it was a major challenge to meet their target cost; however, our team consisting of members from Engineering, VD & Production took this challenge on. We manufactured the disc brake axles within two months of their shortest lead-time and met the target price. This helped Satrac to complete the order for the Indian army ahead of schedule.

The 12-ton disc brake axle is developed with a 5" round and 19mm thick high tensile beam, and has a 400,000 km hub grease life to reduce maintenance cost. The axle is fitted with Wabco made brake calipers.



Disc brake axles will help to improve tyre life in our hilly regions by keeping the temperature of the brake components under control during frequent braking and will contribute to the safety of vehicles by ensuring better braking response and consistent brake performance.

Previously, operators would have to stop their vehicles while coming down from the hilly areas and wait for hours to allow the brakes and tyres to cool down, which wasted a good portion of the trip time. Now they not only get better tyre life but also continue running their trailers in hilly regions without compromising on brake performance and also saving on valuable trip time.



Dussehra Festival Celebrations

Dussehra, the festival to celebrate the victory of good over evil, was celebrated on 23 October with a lot of religious zeal and fervour in India.

Our factory was decorated with flowers & Rangoli art was sketched. The celebration includes worship of Lord Rama & all Machines & Equipment. This was followed by distribution of Prasadam (a satvik vegetarian dish with no eggs, onion, garlic or any masala's in it) to all employees.

Background

Dussehra celebrates the Hindu god Rama's victory over the demon king Ravana and the triumph of good over evil. The epic Ramayana, one of two Sanskrits, tells the story of the Lord Rama who wins the lovely Sita for his wife, only to have her carried off by Ravana, the 10-headed demon

Ravana's sister, Shoorpanakha, soon fell in love with Rama and his brother Lakshamana and wanted to marry one of them. Lakshamana refused to marry her and Rama could not as he was already married to Sita. Shoorpanakha threatened to kill Sita, so that she could marry Rama. This angered Lakshamana who cut off Shoorpanakha's nose and ears. Ravana, the demon king, then kidnapped Sita to avenge his sister's injuries. Rama and Lakshamana then rescued Sita and defeated the demon king with the help of the monkey god Hanuman and a huge army of monkeys.

What Do People Do?

Many people of the Hindu faith observe Dussehra through special prayer meetings and food offerings to the gods at home or in temples throughout India. They also hold outdoor fairs (melas) and large parades with effigies of Ravana. The effigies are burnt on bonfires in the evening.

Included in the celebrations are:

- > the blessing of household and workrelated tools, such as books, computers, cooking pans and vehicles
- preparation of special foods, including luchi (deep fried flat bread) and alur dom (deep fried spiced potato snacks)
- exchanging gifts of leaves from the Shami tree (Prosopis spicigera) as a symbol of the story of the Pandavas brothers' exile in the Mahabharata stories

Día de Muertos (Day of the dead)

SAF-HOLLAND Mexico

The Day of the Dead ("Día de Muertos" in Spanish) is one of the most ubiquitous traditions of Mexican culture.

While the most easily recognizable aspects are probably the various representations of skulls and skeletons, the one that holds the most meaning for those celebrating is the altar, or ofrenda in Spanish. In many ways, the ofrenda is what the whole celebration is about. To really understand more, it is helpful to know a little about the meaning and the significance of the whole celebration.

History and origins

In many ways, the Day of the Dead is the quintessential Mexican holiday because it seems to blend European Catholic traditions with Pre-Hispanic Mesoamerican influences more clearly than other festivities. Celebrated around 2nd November, it coincides with the Christian All Souls' Day. Scholarly research suggests that the modern celebration is essentially the Catholic holiday with a bit of a Pre-Columbine façade.



The reason it is not a clear-cut story is that the standard narrative that the Day of the Dead has its origins in Mesoamerican celebrations has little evidence behind it. Instead, it seems that many of the native cultures in what is modernday Mexico, and in particular the Aztecs, had practices that in many ways resemble some staples of the Day of the Dead and the *ofrenda* in particular as we know them today.

The Aztecs for example did actually make food offerings to the deceased, and even crafted figurines sculpted from food as representations



of the dead to which the offerings were then made.

The offerings

A typical ofrenda is a simple concept. It consists of a set of items that identify the person to whom it is dedicated along with staples of the celebration such a pan de muerto, a traditional sugary pastry adorned with bone and skull shapes made from the same bread, and marigold petals. The items that identify the person will include photos and personal items that belonged to them, but can also include food other than the traditional ones, which the person particularly enjoyed. They will most commonly be on a table which is adorned with a tablecloth and china paper cut in patterns.

The standard altar will be something like this: a table will be set up, if possible with two levels, by using a smaller flat surface on top, covered with a bright-colored tablecloth and adorned with china paper cut in different patterns.

Photos of the person are placed on the top level, along with their belongings, indicating that the offerings are meant for them. Personal items will vary according to the age of the deceased. However, the overall ritual remains unchanged. The lower level is where the food offerings are placed. Normally it will include traditional Mexican cuisine like tamales and mole, but also fruit such as oranges and sugarcane, as well as food or other items that represent the honored person's particular tastes.




Finally, it will also include a selection of food products particular to the occasion like calaveritas de azúcar (sugar skulls) and pan de muerto.

All of this is because, in the end, the metaphysics of the holiday, so to speak, are not particularly deep and complicated. It is at its core a way to remember loved ones by sharing a meal with them as one would when they were alive. For some people, the ofrenda altar as part of the Mexican culture and is the way to demonstrate all the love and respect for deceased family member.
